The "Environmental Awareness" training for the Phelps Road Project was held at GWSD for all parties required to participate.

An all staff safety meeting was held to discuss the findings of the 2019 2nd Quarter Safety Inspection.

The crew test ran the emergency generator for Emily Lift Station and the Main Pump Station.
