# MINUTES OF THE SPECIAL MEETING OF THE GOLETA WEST SANITARY DISTRICT UCSB CAMPUS, PARKING LOT 32, SANTA BARBARA, CALIFORNIA October 19, 2010

#### **MINUTES**

Upon a motion by Director Meyer, seconded by Director Lewis the Board unanimously approved the minutes of the regular meeting of October 5, 2010 as written.

#### **ACTION ITEMS**

#### 1) Review of October 14, 2010 LAFCO Hearing

Mr. Amerikaner acknowledged that the LAFCO hearing centered on discussion of the two (2) letters that had been sent by the District to LAFCO concerning the City of Goleta's application. He stated that the District had made a presentation in addition to the City of Goleta City Manager and Counsel as well as LAFCO staff. The Commission determined that the application period had not lapsed and that said application was not incomplete and, therefore, the request to rescind the Certificate of Filing was denied. Mr. Amerikaner explained that the Commission directed LAFCO staff to develop a policy with regards to imposing a deadline on filing an application.

However, this action will not affect the current application filed by the City of Goleta. He mentioned that Mr. Braitman was pushing to schedule the hearing for sometime in February 2011. The Commission finally agreed to schedule the hearing for December 2, 2010.

# 2) <u>Proposals from CDM for Phelps Road Trunk Sewer Design; Project Management and Environmental Services</u>

Mr. Nation provided an overview of the project and then turned the meeting over to Mr. Bruce Corwin of CDM who gave a power point presentation that focused on the following topics.

- Background of the Project
- Recommended Alternatives
- New CEOA Document required
- Other permits required
- Environmental permitting
- Permitting costs
- Species of concern

Mr. Nation remarked that the Engineering Committee had met to discuss the project and recommends approval of the proposed amendments by CDM. (10-10-46)

Upon a motion by Director Meyer, seconded by Director Turenchalk the Board unanimously approved both proposed amendments from CDM; Amendment #1 for the Phelps Road Trunk Sewer Design Services (\$271,730) and Amendment #2 for Environmental and Project Management (\$166,345) for the Phelps Road Trunk Sewer.

#### 3) Consideration to purchase a District vehicle budgeted for FY 2010-2011

Mr. Nation provided a brief overview of the purchasing procedure for a new District vehicle. He explained that the Finance Committee had addressed the question of purchasing an extended warranty (6 years or 125,000/miles) at a cost of \$2,110. The Committee had recommended that the Board approve the purchase of a 2011 Ford Fusion Hybrid from Perry Ford of Santa Barbara as the lowest, responsible bidder and to also purchase the 6 years or 125,000/miles warranty. (10-10-47)

Upon a motion by Director Lewis, seconded by Director Turenchalk the Board unanimously approved to purchase a 2011 Ford Fusion Hybrid from Perry Ford of Santa Barbara at a cost not-to-exceed \$28,159.73. The Board also approved the purchase of a 6 years or 125,000/miles warranty for an added cost of \$2,110.
