

District Property Taxes to Schools

property taxes to support their operation and maintenance of water and wastewater treatment. "Enterprise" districts are those that generally have elected governing boards and have authority to charge fees for services. These type districts include sewer, water and other utility districts.

Proposition 98 Guarantee for schools insures a certain percentage of the state budget will be set aside for schools. If the Governor's proposal to shift property taxes is defeated, schools are still entitled to their state guarantee share.

The real issue is whether the taxpayers in this

District should have to pay a substantially higher monthly service charge to help the Governor balance his budget.

n recent months the District has been having problems with more than the normal unacceptable items coming down the system and clogging its pumps. These items include such things as rags, mop heads and disposable diapers.

t is important for the public to be aware that these types of items cause excessive wear and tear and maintenance on our pumps. The sewers are not meant to carry anything but wastewater. Children especially are notorious for flushing the wrong things down the commode. The District has retrieved Barbie dolls, small cars and planes, money, jewelry, clothes and cigarette lighters.

Please caution your children on the proper use of their restroom facility. Adults are requested to not dispose of rags, mop heads and disposable diapers down the commode.

f you are a landlord, it would be a good idea to advise your tenants of this problem since it not only

creates difficulties for the sanitary district but can cause a blockage in your house sewer requiring a plumber and an undeserved expense.


School teachers and administrators are encouraged to inform their students of the problem and ways in which they can help. Schools may contact

Since the inception of this project, the District has incurred expensive legal fees, unnecessarily excessive County Resource Management permit fees and will be paying in excess of \$125,000 in mitigation fees over a three year period to restore and improve the flora and fauna in the area.

The District's focus in the beginning was to rectify an existing problem that could have resulted in a major sewage spill and the eviction of people from their homes.

To date the District has spent approximately \$300,000 on this project not including future mitigation expenses. This represents a cost of \$50.00 per sewer user including mitigation expenses. The taxpayers have paid dearly for the clearing of one District easement.
