At one time it was common practice to flush prescription medicines down the toilet. However, it is now known that flushing medications can be harmful to our environment – affecting both water quality and the health of our oceans and beaches. You can help keep our wastewater free of pharmaceutical contamination every day by joining Goleta West Sanitary District in supporting Santa Barbara County's "Operation Medicine Cabinet."

What should you do with your expired medications?

Drop off stations are located at Sheriff's substations and pharmacies, such as CVS, throughout the County. Residents can deposit all unwanted medications (both prescription and over-the-counter) at the locations listed below.

Do Not Flush...

- Antibacterial wipes; they harm the aquatic environment and block sewer lines, pumps and other facilities. Put antibacterial wipes in the trash!
- "Flushable" diapers; they get stuck on roots that have infiltrated sewer lines.
 Put disposable diapers in the trash!
- Plastics or cellophane. Put them in the trash!
- Toxic chemicals, pesticides, or paints. Take them to a household hazardous waste facility.
- Pharmaceuticals. Find an authorized disposal site.
- Cigarettes or matches. Use an ashtray.

Phelps Road Project Nearing Completion!

The District is pleased to announce the Phelps Road Project will soon be completed.

Goleta West Sanitary District is in the final stages of construction of the Phelps Road Trunk Sewer Line project that has been in planning since 2010. This is essentially the "final phase" of upgrading hydraulic deficiencies in the District's collection system and removing obsolete infrastructure out of the Storke Wetland and returning the habitat to its native state.

The District's local contractor began construction of this \$8.9 million dollar project in June of 2019. With sound financial planning, GWSD was able to fund this project 100% with capital improvement project reserve

funds - no additional funding or rate increases to District customers was necessary to complete this project.

The project included abandonment of approximately 1,000 feet of existing sewer line and removal of the associated manholes from within the Storke Wetlands, installation of approximately 3,800 feet of sewer line along Phelps Road, installation of approximately 1,900 feet of sewer line along Mesa Road, and installation of approximately 900 feet of sewer line extending south along Sycamore Walk from Mesa Road. Our revised pipeline system in this area is not only better for the environment, but it also provides adequate capacity for existing and future needs.

Community members that travel Los Carneros Road on a regular basis will now notice that the unsightly manholes protruding out of that wetland are gone! In cooperation with UCSB's Cheadle Center for Biodiversity and Ecological Restoration, a project restoring the habitat where the manholes were located for the past 50 years is underway.

The District is very appreciative of the patience the community has shown during the construction of this important pipeline project.

Wastewater Generation Study

District Infrastructure Ready for the Future

As part of our commitment to long range planning the District recently retained a local consulting firm to prepare a study of local government's land-use plans to determine if the District has adequate wastewater treatment plant capacity to serve the community into the future. Data was compiled from local, County and State documents in order to predict wastewater generation in certain scenarios including "full build-out" of the District's service area. This project was completed jointly with our neighbor the Goleta Sanitary District. Partnering on this project resulted in cost-savings for both Districts.

The results of the study show that the District has planned appropriately; the currently permitted 3.12 million gallons per day (MGD) capacity rights that GWSD owns in the treatment plant is sufficient to accommodate the community's projected wastewater flows up to and including the projected "full build-out" scenario.

Street Sweeping

Please remember to move your cars on street sweeping day to help keep our creeks, beaches, and wetlands healthy and clean.

Since 1964, Goleta West Sanitary District has been providing street sweeping services to its customers. The District was the first South Coast agency to implement a street sweeping program to remove trash and pollutants from storm water runoff that flows into our creeks, wetlands, ocean, and beaches. Unlike many government agencies, we own and operate our street sweeper, making this service reliable and flexible.

Moving your cars and other items such as basketball hoops off the street on your street sweeping day allows the street sweeper to remove the debris that accumulates along the curb before it goes into the storm drain. This helps us keep our creeks, beaches, and wetlands healthy and clean.
