President Geyer observed that the effective date for a compensation adjustment needs to be renewed. He reported that the Finance Committee had met and discussed the issue of increasing Director compensation. President Geyer pointed out that the Board gives a great deal back to its constituents and a stipend adjustment in compensation is due. He further added that the Board could increase compensation to \$215 or another amount between \$200 and \$215. Director Turenchalk stated that she sees value in resetting the stipend.
