**10. CONSIDERATION OF CALPERS EMPLOYER CONTRIBUTION FOR HEALTH CARE INSURANCE FOR CALENDAR YEAR 2025**

The District provides employer paid health insurance coverage for employees and retirees. The Board will consider and choose what plan it will provide employees in 2025 and adopt Resolution No. 24-832 that memorializes the chosen coverage and which will be submitted to California Public Employees' Retirement System (CalPERS).

**11. RECONSIDERATION OF THE CONDITIONS CONSTITUTING AN EMERGENCY AND RATIFICATION OF TIERRA CONTRACT**

- a. On November 5, 2024, the Board adopted Resolution No. 24-831 declaring an emergency and authorizing the General Manager to take all necessary actions to address the emergency. The Board will review the conditions warranting an emergency and will, by a 4/5 vote, make a determination on whether there is a need to continue the action.
- b. The Board will be asked to ratify an agreement with Tierra Contracting for repair of failure point of 24-inch force main that resulted in the October 30, 2024 Spill for a not-to-exceed amount of \$15,000.
