GOLETA WEST SANITARY DISTRICT Operating Report for August 26 – September 8, 2015

I. Administration

Completed routine administrative duties.

Staff reviewed and made comments on the Draft Actuarial Health Liabilities Study (CERBT) prepared by Total Compensation Systems, Inc.

Bartlett, Pringle & Wolf the District's Auditors continue their field work for the annual 2014-2015 audit.

Change Order review and discussions with the contractor on the Mesa Road Project continue.

Staff worked with the Airport Badging Office to renew some expiring security badges and to get new keys for the field crew.

Following Board approval, staff sent a letter to the owner of 11 Daffodil Lane informing them of their permit extension.

Took delivery of the 2015 Chevrolet Pick-up that was included in the 2015-16 Budget. The low bid was received from Rio Vista Chevrolet at \$20,959.

Provided annual street sweeping data to the City of Goleta for their annual storm water report to the Regional Water Quality Control Board.

The District is once again signed up to display two vehicles at PEP's Touch-A-Truck event. This year it is scheduled for September 20^{th.}

II. Collection System Maintenance

The crew completed hydro-cleaning hotspots throughout the District.

Sewer maintenance operations are summarized on the attached sheet.

The crew continued to clear District easements per the usual procedures at this time of the year.

The crew performed the routine monthly test runs of equipment and valve exercising throughout the District.

Staff performed final inspections and completed permits for several units in the Quiet Frenzy Development and Hollister Village Development.

The crew is currently inspecting the off-site sewer improvements for the Village at Los Carneros Project.

Brian McCarthy and Ken Spencer attended NASCCO standardized pipeline, manhole, and lateral inspection certification training at Montecito Sanitary District.

Staff received safety training on Work Zone Traffic Safety.

III. Industrial Waste

Staff collected Industrial Wastewater Discharge Permit compliance samples from two Raytheon facilities.

Staff collected Non-Industrial Source Control (NISC) samples from three (3) designated locations within the District.

Staff conducted a site inspection of the new FLIR Systems facilities on Hollister Avenue. Staff will be issuing a Class 4C Industrial Wastewater Discharge Permit once all fees have been paid.

Staff signed off on a Grease Interceptor installation permit at Home Plate Restaurant at 7398 Calle Real, Suites C & D.
