Administration

2017 Board Meeting minutes were sent out for binding per usual process.

General Manager completed the annual training required to continue as the signatory authority for the District to continue airport access. Each member of the field crew has an airport badge for access.

Staff attended Management Committee meeting.

Staff attended the monthly SBCCSDA Chapter meeting.

Staff continued the work with Counsel and UCSB to prepare drafts of the Easement and License Agreements required for the Phelps Road Project.

Continued work with District Counsel to finalize draft Ordinance regarding GWSD fees.

Staff compiled list of items for consideration for disposal by the District.

Completed Cal/OSHA form 300A and posted as required.

Prepared and submitted electronic reporting for the Case Tractor to California Air Resources Board as required.

Prepared and submitted the 2017 Annual Report for the stationary emergency generator to Santa Barbara APCD.

Issued a Notice of Completion for the Facilities Engineering Phase VI Project.

Collection System Maintenance

The crew completed hydro-cleaning lines in the Cannon Green area and completed the Industry West area near the intersection of Storke & Hollister (this work was done late night-early morning hours). Currently working in the Dos Pueblos High School area and on hotspots and root cutting throughout the District. A Sewer Operations Summary is included with this report.

The crew replaced the pump in the groundwater well for the diversion structure next to Pump Station #1 with a more robust unit. The older style pump had become problematic the past couple of years.

Nu-Line Technologies completed all pipelining and manhole rehabilitation for the Phase VI Pipeline and Manhole Maintenance Project. Upon final review of post-work CCTV video, a defect was found on one tophat lateral joint seal. They are sending up a crew to remove and replace the bad tophat. This is scheduled for February 2, 2018. Once this repair is finished this project will be complete.

District Staff completed final inspection on a People's Self-Help Housing building on Lot 5 in the Village at Los Carneros.

Preliminary plan check was completed on plans for the PS#1 wet well rehab which will be included with the buildings project.

District Staff continues inspecting the public sewer portion of the Village at Los Carneros Project as needed. Several units have received final inspection in the past couple of weeks.

Staff continues working with a consultant to improve communications and reliability of District's SCADA (Supervisory Control and Data Acquisition) system.

Staff continues monitoring Granite Construction as they work on the City of Goleta's Hollister Avenue bike path project which requires raising and/or lowering some of the sewer manholes in that area and the raising of sewer manholes in areas affected by the City of Goleta 2016-2017 Pavement Overlay Project.

Staff received safety training on confined space escape air-packs, Vactor hydro-cleaning operations, review of Cal/OSHA Wildfire Warning & Recommendations and the 4th quarter facility safety inspection summary.

Tenant improvement plans were reviewed for 150 Castilian Drive (Serimmune) and 6583 Pardall Road (Rincon Brewery).

Industrial Waste

District Staff continues FOG inspections for the period.

Staff attended FOG Program Webinar hosted by CSRMA.

Staff met with representatives of Serimmune, Inc., a new biotech company currently undergoing tenant improvements at their new facility at 150 Castilian Drive, Suite 100. Staff is in the process of issuing an Industrial Wastewater Discharge Permit to this facility. They will be subject to Local Limit regulations.

Staff continues to correspond with Corning Technology Santa Barbara currently carrying out tenant improvements at their new facility at 55 Castilian Drive. This will be a semiconductor manufacturing facility subject to Federal Categorical Pretreatment Regulations. Staff is in the process of issuing a Class 4C Industrial Wastewater Discharge Permit to this facility. They will be subject to Federal Categorical regulations.


