APPROVE THE ORDER OF THE AGENDA

There was no change to the order of the agenda.

PUBLIC INPUT

There was no public input presented at this time.

MINUTES

(12-03-11)

Upon a motion by Director Lewis, seconded by Director Geyer the Board unanimously approved the minutes of the regular meeting of February 7, 2012 as written.

ACTION ITEMS

1) Financial Plan Study Report

Mr. Nation introduced Mr. Pardiwala. Mr. Pardiwala provided a Power Point presentation of the Financial Plan Study Report. He addressed the assumptions used in the study, some of which consisted of inflation factors. Mr. Pardiwala then spoke about growth factors to include property taxes, interest, UCSB new connections and account growth. He discussed changes in O&M expenses, revenues and capital expenditures. It was mentioned that a sizeable amount of reserve funds will be used between 2012-2014 for capital projects. Directors Bearman and Meyer expressed concern about the reserve levels becoming too low and are reluctant to enter into any new debt financing. Mr. Pardiwala next addressed the dedicated capital projects and revenue adjustments. Director Geyer suggested that the District wait to raise rates until bids are received for the Mesa Road Project. Mr. Pardiwala replied that the District should examine the rates again in December 2012 and then bring suggestions to the Board in January 2013.

(12-03-12)

Upon a motion by Director Lewis, seconded by Director Geyer the Board unanimously approved to accept the Financial Plan Study Report as presented and to update the report in December 2012 and return it to the Board in January 2013.

2) Consideration of bids for purchase of new Street Sweeper

Mr. Nation explained that the Engineering Committee had reviewed the bids and recommends that the Board accept the bid from Haaker Equipment Co with the "Tier 4" engine option.

(12-03-13)

Upon a motion by Director Geyer, seconded by Director Turenchalk the Board unanimously approved to accept the bid from Haaker Equipment Co. with the "Tier 4" engine option at a cost not-to-exceed \$253,613.33.

President Meyer provided a report on the February 27, 2012 SBCSDA Chapter Meeting.


FUTURE AGENDA ITEMS

staff to contact Goleta Sanitary District to arrange a date for the tour. The Board wished to meet at 12 noon.


ADJOURNMENT

Operating Report for February 1 - 28, 2012

I. Administration

Completed routine administrative duties.

Prepared Board Agenda packet for March 6, 2012 regular Board Meeting.

Completed 2012 CASA Salary & Benefit Survey.

Completed January 2012 Financial Report.

Completed CSRMA 2012-2013 Payroll Reporting Form.

Completed 2012 Government Fleet Smog Check Program Annual Reporting Transmittal.

Distributed 2011 Form 700 to all District Directors, General Counsel and associated staff.

Completed Pull Program enrollment for J. Hilliard.

Attended LAFCO Ad-Hoc, Public Relations and Finance Committee Meetings.

Staff attended the SBCSDA monthly Chapter Meeting.

Attended SAMA Meeting.

Reviewed bids received for the purchase of a new street sweeper.

Sent no-spill certification for January 2012 to the State CIWQS as required. Note that another month of no-spills put GWSD at only one spill in over two years.

Provided a fee estimate to 870 Camino Del Sur. The project is a 56 ERU development.

Staff worked with Counsel to review the LAFCO MSR and Sphere of Influence information provided by LAFCO staff.

II. Collection System Maintenance

The crew continues CCTV inspections, primarily in the Los Carneros Rd. and Storke Rd. areas. 7,452 ft. inspected this period

The crew completed hydro-cleaning the Westfield area. 2,239 ft. cleaned since the last report.

The crew completed hydro-cleaning hotspots throughout the District. 6,696 ft. cleaned since the last report.

The crew completed hydro-flushing throughout the District. 5,660 ft. cleaned since the last report.

Ayala Contracting rehabilitated 2 manholes that needed recoating due to the Cathedral Oaks/Hwy 101 Overpass Project and the necessary adjustment of the manholes to grade change.

Tierra Contracting replaced an approximately 100 ft. section of main sewer in Isla Vista. The pipe defect was found during routine line cleaning. District staff inspected.

Staff has been responding to odor complaints from 2 residents at the new UCSB Campus Faculty Housing. Staff is working with UCSB and the residents to determine the source of the intermittent odor. District staff does not think it is sewer related at this time.

The crew performed routine exercising of:

- Emily emergency generator
- Main facility emergency generator
- Roiline emergency pump
- Exercised all valves

A technician from George T. Hall completed repairs to the telemetry for the flow signal from GWSD to GSD.

Staff attended the Goleta Slough Management Committee meeting.

Staff received safety training on Defensive Driving and Task Safety Analysis: CCTV and Vector Operations.

III. Industrial Waste

Staff completed the 2011 Annual Pretreatment Report and delivered it to GSD.

Staff attended the Annual Pretreatment Conference in Huntington Beach.

Staff attended ISCO sampler training at El Estero WWTP.

Staff issued a Notice of Violation (NOV) to BEI Sensors on February 1, 2012 via certified mail for not submitting their 2011 Fourth Quarter Self Monitoring Report by the due date of December 31, 2011. The NOV required BEI to submit the report within 10 days of receipt of the NOV. The NOV was received at BEI on February 2, 2012. On February 22, 2012 the report was submitted, but because the required report was more than 45 days late, the District was required to find them in Significant Non-Compliance (SNC) per Federal Regulations. SNC requires the District to publish BEI's SNC status in the legal section of the local newspaper.

Staff received and reviewed January well water discharge estimates from Raytheon for water used in their industrial processes and discharged to the GWSD collection system.

Staff received and reviewed January Groundwater Remediation System discharge meter readings from OTIE, Inc. for the Raytheon B-2 clean-up site.
