Administration

Staff attended Engineering Committee meeting.

Worked with District Counsel to finalize draft Ordinance regarding GWSD fees.

Staff is putting together a list of items for the Board to consider for disposal.

Working with District Counsel to develop a funding policy for the PARS Pension Trust to return to the Finance Committee with.

Collection System Maintenance

The crew responded with the CCTV truck to Newport Drive. The resident complained of a backup with their sewer. The crew was able to show the resident photos taken by the CCTV equipment that showed there were heavy roots coming down their private lateral.

Nu-Line Technologies completed all pipelining and manhole rehabilitation for the Phase VI Pipeline and Manhole Maintenance Project. The only remaining work on the project is a small amount of post lining CCTV work. They are expected to be 100% done this week. District Staff is inspecting this project.

District Staff continues inspecting the public sewer portion of the Village at Los Carneros Project as needed. Several units have received final inspection in the past couple of weeks.

Staff continues working with a consultant to improve communications and reliability of District's SCADA (Supervisory Control and Data Acquisition) system.

Staff continues monitoring Granite Construction as they work on the City of Goleta's Hollister Avenue bike path project which requires raising and/or lowering some of the sewer manholes in that area and the raising of sewer manholes in areas affected by the City of Goleta 2016-2017 Pavement Overlay Project.

Staff continues working with MNS Engineers to complete some GIS map update/corrections that are needed on the collection system maps.

The crew completed January monthly maintenance including exercising emergency equipment and exercising all the valves in the District.

Staff sent a map to The Gas Company Representative from GIS showing locations of sewer facilities in the vicinity of Hollister and Entrance Road.

Staff received training on Fire Safety & Hands-on Fire Extinguisher Use.

Annual service was performed on all the fire extinguisher in the District.

Industrial Waste

District Staff continues FOG inspections for the period.

Staff completed the annual Industrial Wastewater Discharge Permit renewal process with all permitted industries within the District.

Staff conducted a site visit to Corning Technology Santa Barbara's new facility at 55 Castilian Drive. This will be a semiconductor manufacturing facility subject to Federal Categorical Pretreatment Regulations. Staff is in the process of issuing a Class 4C Industrial Wastewater Discharge Permit to this facility.
