November 13, 2019 - November 26, 2019

#### Administration

Staff continues working with Sudhir Pardiwalla at Raftelis on the project reviewing the District's miscellaneous fees.

Staff completed the no-spill report on the State CIWQS system as required for October 2019.

Staff attended the Goleta Water District 75 year anniversary event at the Corona Del Mar Treatment plant.

Staff attended a Finance Committee meeting and a Management Committee meeting.

Staff attended the monthly SBCSDA Chapter meeting.

#### **Collection System Maintenance**

Staff corresponded with property manager James Nguyen regarding backup in private sewer collection system at the Grove Condos & Apartments. This was not a GWSD issue. The Grove contacted a private contractor who remedied the problem.

Duthie Power Systems was on site to perform the annual service and load bank test on the main facility emergency generator and the trailer mounted emergency generator.

The District's Electrical contractor and staff replaced the electric motor for the air circulation system in the Angle Support Structure (Diversion Structure).

Contractor Zebron completed rehabilitating several manholes that had infiltration and/or existing coatings failing.

The crew completed the routine safety checks, monthly exercising and checking of equipment and facilities throughout the District for the month of November.

The crew continues with the routine cleaning schedule. Hotspots, Root Cutting and the Westfield area sewers were hydro-cleaned this period. The crew also hydro-flushed scheduled line segments throughout the District. A sewer operations summary is enclosed with this operations report.

The Phelps Road Project continues moving along well this period. Tierra Contracting continues progressing in a timely manner. Current progress - pipe is installed down the Sycamore Walk bike path. The tie-in at the existing 24-inch pipe will be complete on November 27, 2019. Water will be flowing on the new pipeline from the tie-in on Sycamore walk to Mesa Road once the tie in is complete and tested.

Staff continues inspecting as needed at the Village at Los Carneros development. They are getting close to receiving final approval and dedication of the facilities to the District.

The crew completed final inspection and signed off permits for the following:

• Islamic Center of Santa Barbara at Los Carneros/Calle Real

Safety training was held in-house on disaster operations and safely working around gas or electrical lines.

Ruben Chavez renewed his AOA airport security badge.

#### **Industrial Waste**

Staff continues the process of renewing 2020 Industrial Wastewater Discharge Permits.

Staff responded to public records request from EFI Global for 125 and 175 Cremona Drive. These buildings have been occupied by Industrial Wastewater Discharge Permitted industries, but our records indicate that they have all been in compliance.

The crew continues FOG inspections at all the food service establishments in the District.
