ACTION ITEMS

1) Update on Goleta Sanitary District Plant Upgrade Project

Mr. Kamil Azoury provided a review of the Goleta Sanitary District Plant Upgrade Project. He explained that the reason for the upgrade was to move from a blended facility to a full secondary facility. He went on to say that there has been a great deal of permitting involved in the upgrade partially due to the fact that the facility is situated over an old Indian site, it is located in a Corps of Engineers flood plane and is also the nesting site for identified migrating birds.

Mr. Azoury commented that the District has a 10-year agreement with the hauler of their biosolids for \$39/ton.

Mr. Azoury informed the Board that there was a prequalification process established as part of the overall bidding process. He added that there were 10 qualified bidders and 7 bids received

for the project. PCL Construction was the apparent lowest, responsible bidder. A Notice to Proceed will be issued on March 15, 2011. The contractor has 800 days to complete the project, which would be May of 2013. Full compliance with the settlement agreement will be established by November of 2014.

2) Resolution No. 11-725: A Resolution of the Goleta West Sanitary District to Tax Defer Member Paid Contributions – IRC 414(h)(2) Employer Pick-Up

Mr. Nation explained that the aforementioned Resolution is merely to comply with the requirements of the IRS and has no material effect on the District. He went on to say that the Personnel Committee had met and recommends that the Board adopt said Resolution. (11-03-12)

II. Collection System Maintenance

The District received a call from the property manager for 6563 Trigo Rd. who called to report a possible sewer spill. Staff responded and immediately determined that it was a water service leak. Staff called GWD and waited at the site until it was confirmed to be a GWD problem.

The crew completed the 2010 CCTV zone. This was primarily the northwest portion of the District. 11,673 ft. inspected since the last report.

Staff has been providing information to CDM for the Capital Improvement Plan update.

An all staff meeting was held to discuss the findings of the Fourth Quarter Facility Safety Inspection. Two Tailgate Safety Meetings were held on Overhead Utility Lines and Battery Servicing and Handling Safety.

III. Industrial Waste

Staff received and reviewed Well Water discharge calculation from Raytheon for groundwater utilized in their industrial processes and discharged to the sewer system.
