Upon a motion by Director Meyer, seconded by Director Lewis the Board unanimously approved the minutes of the regular meeting of June 7, 2011 as written.

## **ACTION ITEMS**

## 1) Discussion of changing official name of the District – Workshop #3

Mr. Brian Robinson of Terrain Consulting furnished an update of the name change process and addressed the importance of developing a new architecture and content for the District's website. President Geyer mentioned that it would be a terrible mistake to mix the name Isla Vista and Goleta West Sanitary District together into one name. He explained that it would be confusing to the general public. President Geyer likes the concept of a new logo and prefers retaining the current name of the District. Director Lewis agreed with President Geyer. Director Meyer, however; suggested that the District choose a name that distinguishes itself from the other Districts in the Goleta area. Director Turenchalk suggested a tag line that includes serving Isla Vista and western Goleta Valley. Ms. Miller made it clear that much of the confusion will stop once the District's identity is changed. Mr. Youngson agreed that the word Goleta is present in a few of the local public agency names, however; a good marketing strategy will address this

Mr. Robinson informed the Board that the concepts discussed at the workshop will be addressed and then presented to the Public Relations Committee. Ms. Miller remarked that the District has a branding issue and needs public awareness and that a visual way to achieve this must be developed.

The Board then viewed a short power point presentation by Terrain Consulting.

Mr. Amerikaner questioned why people visit the website. Following a brief discussion Mr. Robinson explained the importance of how the District ought to communicate with its constituents.

Director Bearman suggested there be a section on the website devoted to school age children.
