Mr. Nation provided an overview of the requirements associated with the adoption of the Mesa Road Mitigated Negative Declaration. He explained that as the lead agency the District must adopt said Mitigated Negative Declaration. Mr. Nation added that no comments were received

Upon a motion by Director Turenchalk, seconded by Director Meyer the Board unanimously approved to adopt the Mitigated Negative Declaration for the Mesa Road Sewer Replacement Project.

3) Consider awarding bid for the Embarcadero Del Norte Sewer Replacement Project

Mr. Nation informed the Board that the bid opening for the Embarcadero Del Norte Sewer Replacement Project took place on December 21, 2010 and that all bids were then submitted to MNS Engineers, Inc. for their review. No irregularities were found. The Engineering Committee and staff had met and recommend that the bid be awarded to Lash Construction as the lowest, responsible bidder.

Upon a motion by Director Turenchalk, seconded by Director Meyer the Board unanimously approved to award the bid for the Embarcadero Del Norte Sewer Replacement Project to Lash Construction as the lowest responsible bidder at a cost not-to-exceed \$337,950.50.

4) Proposal by MNS Engineers, Inc. for Construction Management Services for the Embarcadero Del Norte Sewer Main Replacement Project

Mr. Nation supplied an explanation for the proposal by MNS Engineers, Inc. He remarked that MNS Engineers, Inc. has performed a good job on prior projects for the District and that District staff have been very busy on operation and maintenance tasks. Hiring MNS Engineers, Inc. for the construction management services for this project will ensure that the operation and maintenance schedule remains current.

Staff conducted Industrial Wastewater Discharge Compliance Inspections at the following locations: Raytheon B-1 Campus and B-8, BEI Industrial Encoders, Lockheed Martin SB Focalplane, Delco Groundwater Remediation System, and FLIR Systems.

Staff collected Industrial Wastewater Discharge Compliance Samples from the following locations: Allergan Medical, Calient Networks, DuPont Displays, Cree SB Technology Center, Delco Groundwater Remediation System, FLIR Systems, Heidenhain, Inc.

Staff collected Non Industrial Source Control (NISC) samples from three designated sample locations within the District.

Staff received and reviewed November well water discharge calculations from Raytheon for water used in their industrial processes and discharged to the GWSD collection system.

Staff received and reviewed November discharge meter readings for the groundwater remediation system operated by Hargis + Associates at the former Delco Electronics site.

Staff received and reviewed November discharge meter readings for the groundwater remediation system operated by Campbell Geo, Inc. at the former Joslyn Electronics site.
